after careful examination of the particulars/information contained in the reference one and two cited and the recommendations of the inspecting authority in the reference second cited, the permission authority is satisfied that the conditions prescribed for grant of ~~provis~~ permission have been partly fulfilled and accordingly in exercise of powers conferred under rule 13 of G.O.Ms.No.524 Education dated 20.12.1988 the permission authority hereby grants permission to the management of Vijaya Bharathi ... School, Madanapalle for establishment of Vijaya Bharathi ... School, Madanapalle with classes I to V with one section in each class during the year 1993-1994 without grant-in-aid.

The educational agency is hereby directed to fulfill the following conditions prescribed for granting provisional recognition within a period of two months from the date of issue of these orders and then apply to the recognition authority in the prescribed proforma for grant of provisional recognition. Granting of permission will not confer any right on the educational agency to claim provisional recognition automatically unless the conditions prescribed for this purpose are fulfilled.

1. The management should run the school from its own resources without expecting any aid from the Government now or in future.
2. Adequate play area and garden should be provided
3. Library should be enriched by adding more number of useful books
4. Economic strength should be enriched for all classes.
5. The remaining balance of Rs. 6000/- should be deposited in any nationalised bank in the joint account of District Educational Officer/Correspondent before submitting the proposals for grant of provisional recognition.
6. The tuition fee and admission fee should be collected as per Government rates.
7. Donation either in cash or kind should not be collected.
8. Syllabus and text books prescribed by the State Government/Director should be followed.
9. Service Registers should be opened on behalf of all the teachers.
10. Next higher classes / sections should not be opened without prior permission of the competent authority
11. Fully qualified candidates sponsored by the District Employment officer should be appointed duly following the rules issued in G.O.Ms.No.524 Education, dated 20.12.1980.
12. Proposals should be submitted for creation of 5 unaided posts of Secondary Grade assistants

8. the society shall provide the necessary material even if it costs more than the deposit amount.

9. Economic strength should be maintained in class VIII.

10. FDRs for Rs.12,000/- have matured and they have to be re-deposited.

11. permission for creation of one B.Ed.Asst. post without grant-in-aid has also been accorded and it should be filed duly following the rules issued in the G.O.fourth cited.

9. sufficient staff should be appointed as per staffing pattern duly following the rules of G.O. No. 1 Sdn. dated, 1.1.1994 immediately.
10. Separate room for laboratory and library should be provided.

11. Adequate play area should be provided as per GO.Ms.No.1 ^{Edn.} dated, 1.1.1994.
12. Permanent accommodation should be provided for classes VI to X immediately.
13. that the list of Governing body shall be furnished to the Dist. Educational Officer, every year.
14. that the pay structure/fee structure fixed by the governing body shall be got approved by the Dist. Educational Officer, every year.
15. that all the conditions prescribed in the G.O. and other orders which are not specified in this orders shall be complied with.
16. that the school shall not be closed without giving notice both to the parents/Dist. Educational Officer and competent authority at least 6 months before.
17. that the school shall be closed or permitted to be closed only from the date on which summer vacation is declared.
18. that the man society shall submit proposals for renewal of provisional recognition sufficiently in advance i.e., at least 6 months prior to the date expiry of the renewal.
